## CLEANING AND DAMAGES

Costs will vary based on damages or excessive cleaning required, with fines ranging from \$500 to \$1,000. Confetti and loose glitter are prohibited for all indoor and outdoor events. Glass is not permitted at any pool-related events. In the ballroom and conference room, nails and screws are not allowed; only double-sided tape may be used for hanging decorations.

## RENTALS AND CHARGEBACKS

All rentals booked through Walnut Creek Country Club will incur a 25% markup on the vendor's quoted price. This upcharge is required by corporate, as the Club manages all communication and payments with the vendor on your behalf.

## SERVICE CHARGE AND TAX

All F&B, room rental, services and equipment charges are subject to a 22% service charge and applicable taxes, a portion of the service charge may be distributed to certain eligible service employees as part of their wages but is not a tip or gratuity.

## TAX EXEMPTIONS

Exemptions from sales tax will be honored when a valid tax exemption certificate or other required document is presented no later than 10 days prior to the Event. At that time, any tax refund claims must be made directly with the tax jurisdiction. \*Chapter 183 of Tax Code - Tax Exempt Organizations can not claim an exemption on LBW under tax code section 151.310
